I hereby waive and/or abandon any claim of whatsoever nature which I and/or (the participant's name) may have against Centurion Gymnastics Club, its directors, shareholders, employees, contractors, invitees, officials, licensees and or agents as a result of the participation in gymnastics and any other related activity or the utilization of any of Brits Gymnastics Club's facilities or equipment. I furthermore hereby indemnify and hold harmless Brits Gymnastics Club, its owner, coaches , employees, officials, licensees and or agents from any damage of whatsoever nature, which shall include but not be limited to non-consequential damages, which I and/or (the participant's name) may incur as a result of the participation in gymnastics and any other related activity or the utilization of any of Brits Gymnastics Club's facilities or equipment. In the event of any accident and/or emergency, I hereby irrevocably and unconditionally authorize that I and/or (the participant's name) may be transported to the nearest medical facility for treatment. Payment Policies

TERMS AND CONDITIONS FOR 2023 –

FEES 1. Tuition fees

1.1. Tuition is calculated and invoiced per month.

1.2. Tuition fees are based on approximately 9 weeks per term. The number of weeks will vary per term, some terms may have more or less weeks and therefore no adjustments will be made to the fees should there be fewer weeks in the term.

1.3 Our terms correspond with the public-school terms and not the Independent/private school terms.

2. New members

2.1. The membership fee of R400 per gymnast/ R700 per family is payable immediately on enrolment to secure the class before training can be attended.

2.2. Failure to pay the membership will result in the child being removed from the class and the place will be offered to the next person on the waiting list.

2.3. Pro rate invoicing will be done for members who enrol after the month has commenced. Classes can unfortunately not be kept, except if paid for.

3. GSA (Gymnastics South Africa) Competitive Programme Jnr and Senior competitive Levels.

3.1. Gymnasts who are identified to participate in GSA competitions have to be registered with GYMNASTICS SOUTH AFRICA.

3.2. This fee (+-R750 per gymnast) is not included in the normal club membership, tuition fees and competition entry fees.

3.3. The fee will be processed to the relevant gymnasts' accounts during February 2023.

3.4. Gymnasts participating in competitions will be required to purchase the necessary leotards and tracksuits as required for the competitions.

4. Payments

4.1. Fees are payable.

4.2 Monthly payments must be received as follows:

- 1st payment when the with enrolment for new members.
- Payment to be received by the 1st of each month e.g., payment by 01 February for February tuition.

4.3. Payment can be made via EFT (preferred) or cash.

4.4. When making payment via EFT please use the gymnast's name and surname as reference.

6. Invoicing and Statements

6.1. Invoices will be sent monthly on 25th of each month and Statements will be send on the 2nd of each month. It remains your responsibility to ensure that payment is received on time.

7. Unpaid fees

7.1. If fees are unpaid for one month it will result in suspension of training and the gymnast will not be allowed to participate in class until the account is paid up to date.

7.2. If fees remain outstanding, then the gymnasts will be removed from the registers and the place will be allocated to the next person on the waiting list.

7.3. The account will be handed over to our debt collection agency.

8. Cancellations

8.1. One calendar month's written notice is required for cancellation of membership in term 1 to 3 (April, May June, July August, September).

9.2. No cancellation of membership can be done in the 4th term (October, November, December) (the full-term fees will be payable).

9.3. The member will be liable for fees until the written cancellation has been received together with the notice period applicable from date thereof.

9.4. We hereby request that parents honor the cancellation policy as the Centre experiences unnecessary losses when we are not informed that a gymnast is not returning to class. No other gymnast can be placed in the class until the register is amended and your child is dropped from the class. This can only happen once we received your cancellation notice. Please note that there are no classes on Public Holidays.
